Dear Customer,

With the approaching end of the year 2024, we beg to turn your attention to certain measures taken by Komerční banka, a.s., a Foreign Bank's Branch, regulating the submission of payment orders at the bank's point of sale or via electronic banking services during the last days of the year.

**The bank's point of sale** will be operating at usual working hours in the last days of the year 2024. The exception is December 31<sup>st</sup>, 2024, when the bank's point of sale will be closed at 1.00 pm.

## 1. SEPA PAYMENTS (DOMESTIC AND CROSSBORDER), SEPA DIRECT DEBIT AND INTRABANK PAYMENTS

Komerční banka, a.s., a Foreign Bank's Branch will accept SEPA payment orders until 31<sup>st</sup> December 2024 inclusive. If you wish to be sure that your orders are executed and settled by the payer's and payee's bank before the end of 2024, please deliver your payment orders to Komerční banka, a.s., Foreign Bank's Branch by the below deadlines.

### **1.1 PAPER-BASED ORDERS**

Orders for SEPA standard payments, to be settled by the payee's bank before the end of 2024 should be submitted.
 At the bank's point of sale by Monday, 30 Dec 2024, 4 pm at the latest; the required date of payment (due date) should not be later than 30 Dec 2024.

Orders for SEPA priority payments which should be settled by the payee's bank before the end of 2024 (while the crediting of the funds to the payee's account depends on the payee bank's processing), should be submitted.

At the bank's point of sale by Tuesday, 31 Dec 2024, 1.00 pm at the latest; the required date of payment (due date) should not be later than 31 Dec 2024.

**Orders for real-time EuroPayments**, which should be settled by the payee's bank before the end of **2024** (while the crediting of the funds to the payee's account depends on the payee bank's processing), should be submitted.

At the bank's point of sale by Tuesday, 31 Dec 2024, 1.00 pm at the latest; the required date of payment (due date) should not be later than 31 Dec 2024.

Orders for SEPA payments or payments in a foreign currency to be credited to clients of Komerční banka, a.s., and Foreign Bank's Branch, which should be settled before the end of 2024, should be submitted.

At the bank's point of sale by Tuesday, 31 Dec 2024, 1.00 pm at the latest; the required date of payment (due date) should not be later than 31 Dec 2024.

Orders for SEPA payments to credit clients of Komerční banka, a.s., in the Czech Republic which should be settled before the end of 2024 should be submitted.

At the bank's point of sale by Tuesday, 31 Dec 2024, 1.00 pm at the latest for due date 31 Dec 2024.

**Orders for SEPA Direct Debit**, which should be settled by the payee's bank before the end of **2024** (while the debiting of the funds to the payer's account depends on the payer bank's processing), should be submitted.

At the bank's point of sale by Friday, 27 Dec 2024, 4.00 pm at the latest; the required date of payment (due date) should not be later than 27 Dec 2024.

### 1.2 ORDERS SUBMITTED ELECTRONICALLY VIA PROFIBANKA

Orders for SEPA standard payments to be settled by the payee's bank before the end of 2024 should be dispatched:

- batch processing under on-line mode in case of non-conversion payments at the latest on Monday, 30 Dec 2024 at 8.30 pm for due date 30 Dec 2024

- In case of batch processing, by Tuesday, 31 Dec 2024, 2 pm at the latest; the required date of payment (due date) should not be later than 31 Dec 2024,
- In case of on-line processing, by Tuesday, 31 Dec 2024, 2 pm at the latest; the required date of payment (due date) should not be later than 31 Dec 2024.

Orders for SEPA payments to credit clients of Komerční banka, a.s., in the Czech Republic which should be settled before the end of 2024 should be dispatched:

**by Tuesday, 31 Dec 2024, 3.00 pm** at the latest for due date **31 Dec 2024** 

Orders for payments made in EUR or a foreign currency, or EUR collection orders, with respect to clients of Komerční banka, a.s., a Foreign Bank's Branch, which should be settled before the end of 2024 should be dispatched:

- batch processing under on-line mode in case of non-conversion payments at the latest on Tuesday, 31 Dec 2024 at 8.30 pm for due date 31 Dec 2024
- batch processing under on-line mode in case of conversion payments at the latest on Tuesday, 31 Dec 2024 at 5 pm for due date 31 Dec 2024
- batch processing under the batch and continuous mode at the latest on Tuesday, 31 Dec 2024 at 6 pm (except of conversion) for due date 31 Dec 2024
- on-line processing in case of non-conversion payments at the latest on Tuesday, 31 Dec 2024 at 8.30 pm for due date 31 Dec 2024
- on-line processing in case of conversion payments at the latest on Tuesday, 31 Dec 2024 at 5 pm for due date 31 Dec 2024

Orders for SEPA Direct Debit should be dispatched for batch processing and on-line processing at the latest on Friday, 27 Dec 2024 at 8.30 pm for due date 27 Dec 2024.

# 2. FOREIGN PAYMENTS

Komerční banka, a.s., a Foreign Bank's Branch will accept foreign payment orders until 31 December 2024 inclusive. If you wish to settle your obligations to your business partners before the end of 2024 (i.e., with value date in 2024), please deliver your payment orders by the below deadlines.

Credit of funds to beneficiary's account depends on the beneficiary's bank processing terms.

Orders for payments abroad in CAD, CHF, CZK, DKK, EUR, GBP, NOK, SEK and USD with standard processing speed submitted via Profibanka on a business day by 11.00 am on-line or batch processing under the on-line and continuous mode with the same due date or at the bank's point of sale by 10.30 am with the same due date we transmit for futher processing so that the funds have been credited to the beneficiary's bank account on the due day of the order, but no later than the deadline specified in the Terms and Conditions of the Provision and Use of Direct Banking and in the Notice on the Payment Transactions.

Orders for foreign payments to credit other bank's clients should be submitted at the bank's point of sale: In case of standard payments:

- in JPY by Monday, 23 Dec 2024, 3.30 pm at the latest for due date 27 Dec 2024,
